

# Insurance Forfait +

## EXPENSES FOR SEARCH & RESCUE

All expenses incurred

- Accident on the skiable with or without skis (with intervention by the service authorized for evacuation).

## TRANSPORT

Expenses for transport of any kind (primary, secondary, return to the station...)

- To the limit of expenses billed during the period of validity of the package, subject to deduction and only in addition to benefits paid by the healthcare plan with which the insured is affiliated and additional benefits (supplemental insurance).

## INTERRUPTION OR POSTPONEMENT OF PACKAGE

Indemnification calculated on prorated basis, insurance deducted

- Access to resort area impossible
- Inability to ski, subject to medical documentation, accident, death
- Dismissal, transfer or divorce

## CANCELLATION OF PACKAGE

Indemnification of total price insurance deducted

## MEDICAL EXPENSES

Expenses required and incurred **MEDICAL EXPENSES** during the period of validity of the package, limited to one month for the season package

- Subject to deduction and only in addition to benefits paid by the healthcare plan with which the insured is affiliated and additional benefits (supplemental insurance).
- Coverage limit: 3500 €
- For foreigners: coverage starting from the first euro upon presentation of originals of supporting documentation.

## EQUIPMENT RENTAL SKI COURSES

Maximum guarantee: 153 € (for equipment rental). Real expenses (for ski courses).

- In case of cancellation or interruption of package for a known cause.

**The insurance deductible up to 20 € for all the guarantees excepted for costs rescue, transport and search**

**Within 5 days, send the insurer:**

- 1 Your declaration of incident accompanied by a copy of the package or of the original if it is a season package.
- 2 Supporting documents: medical certificate or other and copy of initial medical instructions for care.
- 3 Your contact information: last and first names, address, telephone, email.
- 4 A copy of a piece of identification.

## SPECIAL CONDITIONS

### EXTRACT OF FORFAIT+ INSURANCE

#### ARTICLE 1: Definitions

**Insurer:** Special Lines Group on behalf of Groupama Rhône-Alpes Auvergne - Caisse régionale d'Assurances Mutuelles Agricoles de Rhône-Alpes Auvergne - 50 rue de Saint Cyr - 69251 LYON Cedex 09 - SIRET no. 779 838 366 000 28 - Company governed by the Insurance Code and subject to regulation by the Autorité de Contrôle Prudentiel et de Résolution - 61 rue Taitbout - 75009 PARIS

#### The insured is the holder of the package for:

- Guarantee for Cancellation - Interruption (on prorated basis),
- Guarantee for Equipment Rental,
- Guarantee covering expenses for Rescue and Medical Expenses.

For any purchase of a day package, only the guarantee for Expenses for rescue, transport and search is valid for the day, and the guarantees only take effect on the date of subscription of the insurance.

**Stay Package:** Package purchased from the subscriber (under pre-sale or immediate sale) and ski courses.

**Grand Massif Season Package:** Package issued by the subscriber, valid from 15/12/2018 to 22/04/2019 and during the periods of reopening and prolongation:

**Territoriality of the guarantees:** Over the entire skiable and cross-country ski domain, ticket desks and surrounding areas over 150 m, associated with the package and including reciprocity of the package sold by the Subscriber. For season packages, the guarantees are in effect over the entire metropolitan territory and in the foreign domains managed by the Compagnie des Alpes starting from the date of purchase of the package.

**Indemnification:** the day on which the causal event occurs is not indemnified, regardless of the time of occurrence of the event. Indemnification will begin for the causal event (accident, illness ...) specified by the date of establishment of the medical certificate. The package used, even as a pedestrian, is not indemnified.

**Deductible:** a flat deductible of 20 € will be applied for each guarantee (specific deductible for season package), excepted for costs rescue, transport and search. In case of application of several guarantees, a single deductible of 20€ will be applied.

#### ARTICLE 2: Closing of skiable domain

Due to absence of snow or excessive snow: If, in the 48 hours preceding or following the date specified for the start of the package, more than 2/3 of the skiable domain corresponding to the package sold are closed based on a snow alert or if the connection by mechanical lift or trail is closed for more than 24 consecutive hours during the duration of validity of the package, reimbursement, on a prorated basis, of the total amount of the package, insurance deducted.

**ARTICLE 3: Access to resort area impossible**  
Indemnification of the total price of the INSURED package, insurance deducted, in case of impossibility of reaching the resort on the start date of the package and in the 5 following days due to blockage, strikes, flooding or natural events.

#### ARTICLE 4: Serious illness, accident, death

Indemnification of the total price of the INSURED package, insurance deducted, in case of cancellation due to illness, accident or death of the holder of the package, his spouse or common-law spouse, their ascendants or descendants, brothers and sisters, sons and daughters in law. In case of a season package, the insurer intervenes starting from the 6th day.

**ARTICLE 5: Dismissal, transfer or divorce...**  
Indemnification of the total price of the INSURED package, insurance deducted, in case of dismissal, transfer, divorce or legal separation of the insured, recorded at the registries of the Court, provided that the dates of the causal event were after the date of purchase of the package.

#### ARTICLE 6: Expenses for search, rescue and transport

If the insured calls upon an authorized and/or certified service for evacuation fol-

lowing an accident, exclusively within the skiable domain of the validated package: coverage of the expenses billed between the location of the accident and the closest or most appropriate medical office or establishment, including the expenses for transport to the location of residence at the resort (administrative fees for billing or collection are excluded).

Repatriation assistance excluded. In case of necessity, see your personal insurer or that of your bank card.

#### ARTICLE 7: Medical expenses

Coverage of medical expenses to the limit of 3500 € after interventions of health insurance organizations for expenses presented and incurred during the period of validity of the package. Limitation to one month starting from the date of the incident for season packages. **No coverage will be issued by the insurer.**

#### ARTICLE 8: Equipment rental

Reimbursement for equipment rental upon presentation of the paid invoice for rental, in case of cancellation or interruption of the stay package for a covered cause. The calcu-

lation will be done on a prorated basis for the period not consumed, to the limit of real expenses and with a ceiling of 153 €.

#### ARTICLE 9: Ski courses

Reimbursement of ski courses planned during the period of validity of the stay package in case of cancellation or interruption of the package for a covered cause. The calculation will be done on a prorated basis for the period not consumed.

#### ARTICLE 10 : Breakage of sports equipment

In the event of accidental breakage of personal or rented sports equipment, we participate in the rental of the identical replacement equipment up to 250, 00 €, upon presentation of the following elements:

- For the rented equipment: a proof of the renter attesting that the damaged equipment was presented to him, the initial bill of rental of damaged equipment as well as the rental invoice of the replacement equipment.
- For personal equipment: the invoice of purchase of the equipment and the rental invoice of the replacement of the equipment.
